By providing and submitting this information, I understand:

- AACE has the right to make changes to the exhibit hall as seen fit.
- Exhibit invoices must be paid before arriving on-site at the Conference & Expo. Exhibitors whose invoices are not paid will not be provided attendee badges or entrance to the exhibit hall.

- Exhibit displays cannot obstruct the line of sight of neighboring booths. Displays cannot extend more than 3 feet in front of the booth.
- Exhibitors are responsible for purchasing electric power to be dropped at booths through the GES Exhibitor Toolkit.

CANCELATION POLICY

Full payment is due within 45 days of contract submission until **May 1, 2026**. Thereafter all payments must be received at the time of contract submission. Onsite payments will not be accepted. If all payments and outstanding amounts are not paid in full by June 28, 2026, AACE retains the right to cancel the Exhibitor's space without further notice and without obligation to refund previously paid amounts. If payment is not received prior to load-in onsite, AACE will not allow for the release of the exhibitor's shipped items, printing of the exhibitor's badges or access to the expo floor. In the event that an Exhibitor/Sponsor wishes to cancel all or part of the contracted exhibit space, the Exhibitor must do so in writing and email to development@acei.org. **Cancellations received on or before May 1, 2026 will receive a full refund, minus a \$250 processing fee.**

WEBINAR SCHEDULING REQUIREMENT

The sponsored webinar must be scheduled and delivered no later than **December 31, 2026**.
